## NOTICE OF RACE

### 1- Organizing Authority

### 2- Rules

The Regatta will be governed by the WS RRS 2017-2020 and OSR, and by additional rules as specified in the Sailing Instructions.

The requirements of the National Authority (Italy) will apply and will be stated in detail in the SI.

### 3- Sailing Instructions

Sailing Instructions will be issued by Club Nautico Scarlino, and given to Skippers on Registration Day.

### 4- Special Rules

No poles allowed (gennakers and drifters admitted).

Boats must be fitted with the complete standard accommodation, and it is strictly forbidden to remove doors, tables, hardware, equipment, mattresses etc.

Dinghies, outboard engines, bow anchor and its chain can be removed.

Boats must have one anchor onboard.

Life rafts onboard are compulsory.

Infringement of these rules will lead to disqualification.

Italian Competitors shall be in compliance with the Italian Sailing Federation membership (“tessera FIV”).

### 5- Ratings

ORC Club rating will be used, with certificates issued by the Italian Association (UVAI) or by any ORC National Authority chosen by the Owner.

A ORC Club or ORC International Certificate shall be submitted, together with the entry form.



## 6- Eligibility and Entries

Participation to the S&S Swan Rendezvous is by invitation only.

This is an event dedicated solely to Sparkman & Stephens designed Nautor's Swan yachts, associated in the S&S Swan Association. It is the intention of the Organizing Authority to divide the fleet into two divisions ( $\leq 44'$  and  $\geq 44'$ ).

Entries will be confirmed only after Entry Form, full payment and insurance documents have been received.

Participants must send their Entry Form with a copy of current insurance certificate, including third part liability extended for the races of a minimum insured value of €1.500.000.
